

Disclaimer

In Spain, Telecommunication Engineering studies encompass specialised subjects that in other countries come from areas of knowledge such as Electronic Engineering, Electrical Engineering, Computer Science, and Control and Process Engineering, among many others. These areas of knowledge are taught in Schools different from ETSI Telecomunicación (ETSIT), such as the School of Industrial Engineering (ETSII), the School of Design Engineering (ETSID), the School of Computer Engineering, etc. Incoming students often come from these branches of study and request subjects from these centres. However, the availability of these subjects in other centres is limited, and they usually fill up with their own students. Frequently, and despite our best efforts to help, we cannot guarantee that the applicant can take these subjects. For this reason, and to avoid unnecessarily prolonging acceptance processes, incoming students must be aware of these conditions and take responsibility for alternatives if they are not accepted in these subjects. This disclaimer includes this issue and common problems that could arise.

The student ID# , confirms

- They know that there is no guarantee of being accepted in courses that administratively belong to other schools of the UPV, which the ETSI Telecomunicación (ETSIT) does not directly manage.
- They have been notified that in case of applying for courses in other Schools, they have to provide the following:
 - A B2 or higher English language certificate in case the course is lectured in English or
 - A **B2** or higher Spanish language certificate in case the course is lectured in Spanish

Their acceptance to these courses depends firstly on submitting the certificates mentioned above and, secondly, on the availability of places.

- The list of courses in the Learning Agreements (LA) sent before arrival is **tentative**, especially if they contain courses from other UPV Schools.
- They have **enough funding** for the whole of their stay in Valencia. Universitat Politècnica de València cannot provide funding to any exchange student.
- If the student wants to do their Bachelor/Master's **Degree Thesis** at ETSI Telecomunicación, they must inform ETSIT's International Office within one month after arrival. At the same time, starting the procedure leads to doing the dissertation within the **deadlines** established by the ETSI Telecomunicación.
- They know they cannot be awarded a UPV degree directly from an exchange program unless **nominated and accepted for a Double Degree** program and accomplish a unique Double Degree studies plan. They must notify of their Double Degree condition in their application and upon their arrival at ETSIT.
- Students who did not attend **two** lectures of any course will be de-registered for that course.



• Lectures and practices are **presential**. Students who arrive later than the dates on the following table might be rejected for the courses even if they are already at UPV:
